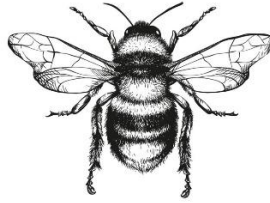

Honeybee Home is an orchestrated group of community vendors who create, find, and design beautiful gifts and home decor. We are a vetted group of artists, antiquers, designers, and lovers of the unique. Our aim is to create one-of-a-kind products and decor that excite and inspire.

Once a season, our hive comes together to present our wares in an over-the-top 2-day indoor/outdoor retail celebration with live music, food trucks, and of course amazing stuff! We decorate Mary's Land Farm to the nine, and lay it all down for our customers. Be sure not to miss the design event of the season on this 160-acre working farm in the heart of Howard County!

Show Dates

SPRING: May 30-31, 2020

TIME: Sat & Sun 10am-5pm

LOCATION: Mary's Land Farm: 4979 Sheppard Ln., Ellicott City, MD 21042

SPACE: 10'x 10' grass space outside enclosed vendor pavilion.

SET-UP: Friday before event date, 10am-5pm / Saturday & Sunday, 8am-9:30pm
(Restocking permitted an hour before the start of each show day)

Fee: \$50/day

ELECTRICITY

(+\$25 flat fee for electricity, regardless of number of spaces rented. Limited number of spaces have electricity)

THE VENUE:

Mary's Land Farm is a 160-acre balanced ecosystem of perennial plants and pasture. Free range ducks, cattle and goats happily graze the grasses in the fields, and the rolling hills and mature trees beckon the visitor to give pause and stay a while. In addition to selling the products they cultivate, the farm also serves as a bed and breakfast and wedding venue.



SET UP:

Set up will be outside the pavilion under your own tent. Your set-up space will be clearly marked for you in the grass. Vendors are responsible for their own set up, staffing, tables, chairs, display pieces etc. Visit Honeybee Home's website for more information on the tag sale and additional photos. www.honeybee-home.com

DURING THE SALE:

We will have a team of haulers to help carry and load furniture for customers. As time allows, they may be available to bring items from your vehicles for restocking. If you use their help, *be sure to tip them.* Vendors are advised to use receipts, bags, etc. to show that their items have been paid for.

INTRA-DEALER SHOPPING:

You are welcome to shop and trade among each other during set-up and after the sale. However, during sale hours, while customers are here, please be discreet about this.

THE WAY IT WORKS:

All of your sales are your own responsibility, including wrapping items and any sales tax remittance. Be sure to provide some proof of purchase for your customers, such as bags, receipts, SOLD stickers, etc. Customers must make arrangements to remove items directly from you. *There will not be a holding area available.*

Mary's Land Farm will be open during the entire event for customers to walk the grounds and enjoy free-range ducks, cattle, and other natural elements. The Farm's welcome center will be selling farm fresh eggs, meat, ice cream, and the full line of Secolari olive oils.

Toilet facilities are outdoor port-a-potties on the West side of the pavilion. Handicap accessible rest rooms are available inside the B&B.

Food will be available on the premises in the form of food trucks.

PARKING:

All vendor vehicles must be off the pavilion grounds/customer parking lot at least 30 minutes prior to opening. Vendor parking is in the field parking area, furthest from the entrance. Vendors are not permitted to park in the paved customer parking area adjacent to the pavilion (this is reserved for handicap parking and loading). Vendor overnight trailer parking is available upon request at the farm at no additional fee.

BREAK DOWN:

Vendors are not permitted to break down / pack up their booth before the end of the show corresponding to the last day in which they agreed to participate. All items must be removed within 2 hours after close of the show.

Vendors are responsible for removing all trash, display items, merchandise and any other show materials upon leaving the leased premises. The leased premises must be cleaned and returned to the condition that it was found upon arrival.

This is a Rain or shine event.

Vendors: Please keep the above pages for your records (you only need to submit 2 pages along with your check to apply for the show: the vendor application page and signed vendor agreement page).

TEMPORARY VENDOR APPLICATION:

Please use this application if you are **NOT** able to be a vendor for both (2) days of the show **OR** if the covered pavilion space is full. This application is for vendors wishing to sell for 1 or 2 days. Vendors accepted under this application will be positioned in the grass around the pavilion and will need to provide their own tent.

Market you're applying: SPRING May 30-31, 2020

EVENT TIME: Sat & Sun 10am-5pm

SET-UP: Friday before event date, 10am-5pm / Saturday & Sunday, 8am-9:30pm
Temporary vendors selling for 1 day may set up on Friday only if they plan to sell on Saturday. Temporary vendors selling only on Sunday must set up the day of the event before the show opens.

The main draw of our event is *vintage* and *handmade*. Please keep mass-produced and reproduced items to a minimum (less than 20%). Mass-produced and/or reproduced items cannot be the focus of your booth, but rather accents (which may also be for sale). If any vendor does not follow these stipulations, they will be asked to remove erroneous products from their booth or instructed to leave the show. Please note that we do not accept applications from multi-level marketing or direct sales vendors such as Pampered Chef, Lularoe, Origami Owl, etc.

Payment must be included with application. You may send payment electronically via PayPal to thehoneybeehome@yahoo.com. Please use “friends and family” to send money through PayPal to avoid fees. If you do not know how to do this, please opt to mail a check. There will be a \$40 charge for any returned check. You may complete the “editable” application on our website and email it to us at the email above, or print and mail it. Regardless, your application is not complete unless we have your application, signed vendor agreement & check made payable to:

VENDOR AGREEMENT

Show Integrity:

I agree that the majority of products that I will be selling (at least 80%) at The HIVE Market will be *vintage* and/or *handmade*. I understand that mass-produced and/or reproduced items cannot be the focus of my booth, but rather accents (which may also be for sale) and understand that if I do not follow these stipulations, I will be asked to remove erroneous products from my booth or instructed to leave the show.

Insurance:

Vendors must have adequate business insurance to guard against loss or damage. Mary's Land Farm and Honeybee Home shall carry liability insurance to cover its responsibility in connection with the event.

Photos:

By signing below, I hereby grant permission to Honeybee Home to use the photos I submitted as part of my application in publications, news releases, online, and in other communications for the purpose of promoting The Hive Market. I also permit Honeybee Home to use any photos/video taken of me or my product to promote future shows. I acknowledge that Honeybee Home has permission to use these photos/videos without reimbursement to myself.

Compliance with Laws:

Vendors handle their own transactions, sales tax remittance, etc. All permits, licenses and inspections required by State and County agencies are the responsibility of the vendor who will supply proof of compliance and satisfactory completion of any and all inspections. The vendor covenants to comply with any and all laws and regulations of the Federal, State, and Local Government which may be applicable to the Leased Premises. The Vendor shall pay all costs, claims, fines, and damages that may arise out of the failure of the Vendor to comply with this section and those below.

Liability:

The vendor acknowledges that Mary's Land Farm and Honeybee Home will not be held liable for any loss or damage to their furnishings or other property. The vendor agrees that they will indemnify and hold and save Mary's Land Farm and Honeybee Home and its members, agents, volunteers, guests and participants harmless of, from and against all suits, loss, cost, liability, claims, demands, actions and judgments of every kind and character by reason of any breach, violation of non-performance of any term, provision, covenant, or condition of this Agreement on the part of the Vendor.
