

Workshop Waiver of Liability

We hope your workshop experience is safe and rewarding, but accidents can happen. The following waiver must be signed by all participants to protect Honeybee Home, LLC and the venue owners from liability.

Waiver: In consideration of being permitted to participate in any way in a Honeybee Home, LLC, Workshop I, for myself, my heirs, personal representatives or assigns, do hereby release, waive, discharge, and covenant not to sue the owners of the venue nor Honeybee Home, LLC (or its employees, volunteers and agents). I release Honeybee Home, LLC and the venue owners from liability from any and all claims resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, risks associated with the use of alcohol; risks associated with the use of alcohol in conjunction with tools or other equipment and participation in the Honeybee Home, LLC workshop.

Indemnification and Hold Harmless: I also agree to INDEMNIFY AND HOLD the venue owners and Honeybee Home, LLC and its employees, volunteers and agents HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in the Honeybee Home, LLC workshop and to reimburse them for any such expenses incurred.

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of Arizona that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding: I have read this waiver of liability, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

Parent or Guardian (if student is under 18): I am the parent or legal guardian of the below named minor child and, as such, I am authorized to enter into this agreement. I agree that my minor child and I are bound by and subject to the terms of this agreement. I understand that my signature here reflects my agreement to hereby release, waive, discharge, and covenant not to sue the owners of the venue nor Honeybee Home, LLC or its employees, volunteers and agents from liability from any and all claims resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in the Honeybee Home, LLC workshop.

The undersigned, does, on behalf of themselves, family members and their estate agree to indemnify and hold harmless Honeybee Home, LLC, its agents, employees, and the owners of the venue from and against all claims, damages, losses, and expenses, including reasonable attorney's fees and court costs, arising out of injury, illness, sickness or disease which may occur as a result of this activity (including death). I hereby absolve Honeybee Home, LLC and the owners of the venue of all liability, including ordinary negligence, including, but not limited to, the following risks and possible injuries from falls, insect/animal bites/stings, or illness from animal encounter, interaction/mishap from implements, tools, equipment or structures on the property (i.e. barbed wire, rusty metal, splintered wood), and damage to vehicle/motor vehicle accidents associated with on-ranch workshops before, during, and after the event.
